Eligibility:

- 1) The admission to the course would be based on a competitive entrance test.
- 2) To be eligible to appear for the eligibility test the candidate should be a graduate in any faculty having scored a minimum of fifty per cent of marks; and should have opted for Mathematics at the higher secondary level or at least at the first year of the degree course.
- 3) Candidate who are appearing for the final examination may also be permitted to apply, but, their admission, if otherwise selected, will be confirmed only after he/she satisfies the eligibility criteria mention in (2) above.
- 4) The eligibility test will comprise of an objective type written paper. Shortlisted candidates may be called for a personal interview and / or group discussion.

Institute level CET – The Institute will conduct CET for the application for deciding the merit list for admission as the University Guidelines for Admission to M.Sc. (Finance) **program.** Admission committee will be supervising the process as per the University of Mumbai guidelines.

Documents required at the time of admission:

Original documents along with two copies of attested documents to be produced at the time of admission.

- a. 10th standard certificate and mark sheet
- b. 10 + 2 standard certificate and mark sheet
- c. Degree, passing certificate and all years mark sheets
- d. Birth certificate / Domicile certificate in case of students applied in reserved
- e. Caste certificate, Caste/tribe validity certificate, non-creamy layer certificate wherever applicable issued by the competent authority
- f. Physically Handicapped Certificate as prescribed by the Government from Competent Authority wherever required

The rules of cancellation are applicable as per the University of Mumbai ordinance 0.3574 relating to the refund of tuition fees etc. in respect of post graduate courses.

University Circular UG/ 253 OF 1996. 0.3574

- 1. The registration fees once paid for the PG course will not be refunded for any reason.
- 2. The Tuition fee paid by the candidate for the course in which he/she is registered as a PG student will be refunded to him/her if he/she leaves the said course without attending any lectures, seminars or practical, subject to a deduction of 25% of the tuition fee. The application by the candidate for such refund will only be entertained if it is received by the Principal/Registrar/Head of Department within fifteen days of the date of commencement of the lectures of the academic year for which the fees is paid.
- 3. The Tuition fee paid by the candidate for the course in which he/she is registered as a PG student will be refunded to him/her if he/she leaves the said course and joins another 42 course of this University for which he/she applied at the same University admission is made later, subject to a deduction of 25% of the tuition fee
